OFFICIAL SUMMARY PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, TETON COUNTY, WYOMING

The Teton County Board of Commissioners met in regular session on **January 25, 2021** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:00 a.m.

Commission present: Natalia Macker Chairwoman, Luther Propst, Vice-Chairman, Mark Barron and Greg Epstein were present via Zoom. Commissioner Newcomb joined the meeting at 9:09 a.m.

SENATOR HENRY COE: Recognition was given for recently deceased Henry H. R. Coe, Wyoming Senator.

ADOPT AGENDA

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to adopt the agenda as presented. Chairwoman Macker called for a vote. The vote showed four in favor and the motion carried 4-0.

PUBLIC COMMENT

There was no public comment.

ACTION ITEMS

1. Consideration of Payment of County Vouchers

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to approve the January 25, 2021 county voucher run in the amount of \$502,748.33. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to approve the tax roll correction as presented by the assessor for Field House LLC totaling \$2,243.12. Chairwoman Macker called for a vote. The vote showed four in favor and the motion carried 4-0.

4. Consideration of Northern South Park Public Participation Program

The Board discussed the Public Participation Program as it relates to the Northern South Park steering committee and as a general policy.

Chris Neubecker, Director of Planning and Building Services, gave updates on the Northern South Park committee meetings.

There was no public comment.

Commissioner Newcomb joined the meeting at 9:09 a.m.

A motion was made by Commissioner Propst and seconded by Commissioner Newcomb to approve the Northern South Park Neighborhood Plan Public Participation Program dated January 12, 2021 as presented. Chairwoman Macker called for a vote. The vote showed three in favor and the motion carried 3-2, with Commissioners Epstein and Barron opposed.

 - i. Health Department: COVID-19 Response Jodie Pond, Director of Health, provided updates on the addition of purple in the risk level color scheme, current COVID-19 cases and hospital capacity, contact tracing, testing options/vaccine hotline, and vaccines.
 - ii. Attorney Erin Weisman, Teton County Attorney, provided updates on new hires, and provided updates through a confidential and privileged letter.
 - iii. Planning Chris Neubecker, Director of Planning and Building Services, provided updates on current projects, the 390 rezone, permits, and revenue received through the department totaling 3.3 million dollars.
 - iv. Engineering Heather Overholser, Director of Public Works, gave updates on Tribal Trails, wildlife feeding enforcement, water quality, current projects, pavement maintenance program, and construction projects including pathways and bridge repairs, Hoback South road realignment, Wilson-Stilson pathway, and Tribal Trail connector.
 - v. Fire/EMS Fire Station 1 Construction provided updates through an email.

WORKSHOP I: SCHEDULE OF FEES - PLANNING & BUILDING SERVICES - CONTINUED FROM DEC. 15, 2020

Rian Rooney, Associate Long-Range Planner, Planning and Building Services, presented updates on the fee schedule.

At the October 20, 2020 Board of County Commissioners meeting, the Board authorized the commencement of the comment period for an update to the Planning & Building Services Department Schedule of Fees, beginning on October 28, 2020. Pursuant to the Wyoming Administrative Procedures Act, a 45-day comment period must be advertised and comments invited prior to adoption of new rules. Following receipt of public comment and additional internal review, staff released an update to the initial draft for consideration on December 2, 2020. At the December 15, 2020 Board of County Commissioners meeting to review the proposed update, the Board moved to continue the item to a workshop on January 25, 2021 for further discussion.

The Planning & Building Services Department has not updated its Schedule of Fees for Planning Permits and Building Permits since 2014, when a revised Schedule was adopted to align with the restructured Teton County Land Development Regulations (LDRs) that went into effect January 1, 2015.

Chris Neubecker, Director of Planning and Building Services, answered questions from the Board.

A motion was made by Commissioner Propst and seconded by Commissioner Epstein to continue review of the update of the Planning and Building schedule of fees to a regular meeting of the Board of County Commissioners for consideration of approval on February 16, 2021. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.
