

**OFFICIAL SUMMARY PROCEEDINGS
OF THE BOARD OF COUNTY COMMISSIONERS, TETON COUNTY, WYOMING**

The Teton County Board of Commissioners met in regular session on **February 20, 2018** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:03am and the Pledge of Allegiance was recited.

PUBLIC COMMENT

There was no public comment.

MATTERS FROM COMMISSION AND STAFF:

1. Consideration of Payment of County Vouchers

A motion was made by Commissioner Vogelheim and seconded by Commissioner Epstein to approve voucher run in the amount of \$513,554.92. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

13. Consideration of Letter to US Representative Cheney and US Senators Barrasso and Enzi Regarding HR 4697

Public comment was given by Shad Free, Mike Mielke, Kevin Kavanagh, Jesse, Combs, Hank Phibbs, Chris Moody, Lloyd Dorsey, Wade Kaufman, Len Carlman, and Mike Carruthers.

Discussion between the Board and staff included letter shows disrespect to Teton County, history of WPLI, support of WPLI process, effect on a nationwide basis, pride everyone has for public lands, "one-click politics" comment apology, current Palisades lawsuits, make sure WPLI process is fair, and support of letter by all Commissioners.

A motion was made by Commissioner Vogelheim and seconded by Commissioner Epstein to approve and forward the letter to the Honorable Representative Liz Cheney as revised dated February 20, 2018 and request that this Board forward a similar letter to the participants in the lawsuits and that we also ask for a workshop for us to check in with the WPLI process and talk through some of the issues brought up today. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

4. Consideration of Amended Decision of Teton County Board of Equalization Docket 2016-0040 – Lockhart Cattle Company, LLC (continued from February 6, 2018)

Sherry Daigle, County Clerk, presented to the Board for consideration of approval an amended order from the Board of Equalization Hearing on July 20, 2016 on Docket No. 2016-0040 for Lockhart Cattle Company LLC. This item was appealed by the County Assessor and was heard by the State Board of Equalization in February 2017. It was remanded back to the Teton County Board of Equalization in October 2017 due to lack of clarity on the decision by this Board.

Discussion between the Board and staff included a hybrid version of the amended order from Mr. Barton.

There was no public comment.

A motion was made by Commissioner Vogelheim and seconded by Commissioner Epstein to approve the proposed amended order by the appellant as presented in the matters of the appeal of Lockhart Cattle Company LLC from a decision of the Teton County Assessor 2016 Property Valuation, State docket #2016- 0041. Chair Newcomb called for the vote. The vote showed 3-1 with Commissioner Rhea opposed and the motion carried.

6. Consideration of Hoback River Bridge Final Acceptance Letter

Sean O'Malley, Director of Public Works, presented to the Board for consideration of approval the acceptance letter with the Wyoming Department of Transportation (WYDOT) stating that Teton County has inspected the newly re-constructed Hoback River Bridge and accepts the project.

Discussion between the Board and staff included other outstanding costs with this reconstruction.

There was no public comment.

A motion was made by Commissioner Epstein and seconded by Commissioner Vogelheim to accept the Hoback River Bridge BROS-OC22031 as complete in accordance with plans and specifications prepared by the Wyoming Department of Transportation and to approve Form LP-3 for submittal to the Wyoming Department of Transportation. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

8. Consideration of Employee Transitional Housing, Hoback Cabins Unit #8

Keith Gingery, Chief Deputy County Attorney, presented to the Board for consideration of approval of a lease agreement for Teton County Employee Transitional Housing for Mallory Marshburn, a new employee with Teton County Parks and Recreation, at 11055 South Highway 89 Hoback Cabins Unit #8.

Discussion between the Board and staff included pet deposit and why is this type of item elevated to the Board.

There was no public comment.

A motion was made by Commissioner Epstein and seconded by Commissioner Vogelheim to approve the Lease Agreement for 11055 South Highway 89, Hoback Cabin Transitional Unit #8 with Teton County Employee, Mallory Marshburn, for \$685 per month and a \$500.00 security deposit. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

14. Consideration of a Letter to 2018 Senate Corporations, elections, and Political Subdivisions Committee Regarding SF 114

This item was continued to the end of the meeting.

The meeting was recessed at 10:08am and reconvened at 10:18am.

MATTERS FROM PLANNING & DEVELOPMENT

1. Findings of Fact and Conclusion of Law: MSC2017-0037 – SRS CLUB, LLC

Erin Weisman, Deputy County Attorney, presented to the Board for consideration of approval the findings of fact and conclusions of law and order denying Miscellaneous Planning Request for SRS Club, LLC.

There was no public comment.

A motion was made by Commissioner Epstein and seconded by Commissioner Vogelheim to approve the Findings of Fact, Conclusions of Law and Order denying a Miscellaneous Planning Request. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

2. Findings of Fact and Conclusion of Law: EXD2017-0006 – 7-C Industries, Inc.

Erin Weisman, Deputy County Attorney, presented to the Board for consideration of approval the findings of fact and conclusions of law and order granting approval of an Exempt Land Division for 7-C Industries, LLC.

There was no public comment.

A motion was made by Commissioner Vogelheim and seconded by Commissioner Rhea to approve the Findings of Fact, Conclusions of Law and Order granting approval of an Exempt Land Division referencing EXD2017-0006. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

Presenter: Jennifer Kocher-Anderson
Permit No.: MSC2018-0005
Request: Consideration of a request for an exception to the Pond/Berm Freeze Resolution 18-002, adopted by the Board of County Commissioners on January 2, 2018, to allow the applicant to revise an existing Grading & Erosion Control Permit for the purposes of permitting berms installed prior to the Freeze Resolution, but not properly permitted.
Location: 2775 W. Dairy Lane (Lot 6B, Dairy Subdivision). Generally located off of south Park Loop Road west of High School Road. The property is zoned Planned Unit Development – Rural 2 (PUD-R2) with no overlays.

Jennifer Anderson, Code Compliance Officer, presented to the Board for consideration of approval a request for an exemption to the Pond/Berm Freeze Resolution 18-002, adopted by the Board of County Commissioners on January 2, 2018, to allow the applicant to revise an existing Grading & Erosion Control Permit for the purposes of Permitting berms installed prior to the Freeze Resolution, but not properly permitted.

Discussion between the Board and staff included that the berms were completed prior to 90-day freeze, side slope is within current specs, pond work and berm work completed - would have required a revision prior to closing out the permit.

Heath Kuszak from Agrotis, Inc. acting as the agent for the applicant addressed the Board regarding the reason for the reasonable exception is because they don't believe the berms compromised the justification or basis for the freeze resolution as it was originally approved.

Public comment was given by Joohee Muromcew.

A motion was made by Commissioner Rhea and seconded by Commissioner Epstein to approve an exception to the Pond/Berm Freeze Resolution 18-002 adopted on January 2, 2018, and find that the application for an exception is reasonable and does not compromise the justification and basis for the freeze on berms, to allow the owners of Lot 6B, Dairy Subdivision to submit a revised application to the Grading & Erosion Control Permit, GEC2015-0022, and request the addition of three new berms as shown on the Agrotis, Inc. as-built drawing titled "Final Conditions, Lot 6B," page GEC4.8, dated 11.08.17, to be processed by the Planning Department. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

- 4. Applicant:** TETON RAPTOR CENTER
Presenter: Kristi Malone
Permit No.: VAR2017-0002
Request: Variance, pursuant to Section 8.8.2, to vary Section 3.2.3.B.2 of the Teton County Land Development Regulations, to allow improvements to be made to an existing 36-foot tall structure that would result in a total structural height of 38 feet where 30 feet is the maximum structure height allowance for the zone.
- 5. Permit No.:** CUP2017-0007
Request: Conditional Use Permit, pursuant to Section 8.4.2 of the Teton County Land Development Regulations, to amend an existing institutional use.
- 6. Permit No.:** ZCV2017-0025
Request: Zoning Compliance Verification for Visual Resource Analysis, pursuant to Section 8.6.2 of the Teton County Land Development Regulations, to assess foreground scenic standards.
Location: Site of Teton Raptor Center and historic Hardeman barns; generally located in Wilson on the south side of Highway 22. The property is zoned R-2 and is located within the Scenic Resources Overlay.

Kristi Malone, Associate Planner, presented to the Board for consideration of approval a Variance, pursuant to Section 8.8.2, to vary Section 3.2.3.B.2 of the Teton County Land Development Regulations, to allow improvements to be made to an existing 36-foot-tall structure that would result in a total structural height of 38 feet where 30 feet is the maximum structure height allowance for the zone.

The proposed Variance seeks a maximum height allowance of 38 feet for the existing North Barn (large gothic-style Hardeman Barn closest to Highway 22) structure where a maximum of 30 feet is allowed in the R2 zone. As it stands, the North Barn is 36 feet tall and is categorized as an existing nonconformity. While maintenance and alteration of nonconforming physical development is permitted per LDR Section 1.9.2.B, replacement of structural support or increasing the nonconformity is not permitted. The barn is proposed to remain in its current location but requires replacement of the foundation, grading for positive drainage, and insulation which will result in raising the maximum height by an additional two feet. The proposed improvements qualify as replacement of structural support and increase in nonconforming height, so a variance is required.

Ms. Malone also presented to the Board for consideration of approval a Condition Use Permit, pursuant to Section 8.4.2 of the Teton County Land Regulations, to amend an existing institutional use.

This Conditional Use Permit application requests amendment to the rehabilitation, education and event components of the Teton Raptor Center's current institutional use. Proposed changes to operational characteristics can be summarized as:

- Raptor Rehabilitation Capacity – Construct a 3,879-square foot indoor flight chamber, rebuild clinic, relocate historic pump house on-site for storage use, and convert historic Horse Barn to raptor research facility;
- Educational Programming – Construct additional raptor mews (raptor housing) for full-time education birds, convert historic North Barn to indoor programmatic space, move outdoor programmatic space from interior of campus to west yard and construct pavilion;
- Staffing – Increase the number of on-site employees from 3 to 12, increase the number of employees housed on-site from one to four by constructing 2 ARUs, and construct staff offices;
- Events – Allow up to 4 mission-based events with more than 100 people each year under a Special Event Permit

All other components of the institutional "non-profit bird education and care facility" are proposed to remain consistent with the standards and conditions of the effective 2008 Conditional Use Permit (CUP2008-0001). These persisting allowances include conducting classes, workshops, and flight exhibits for less than 100 people, housing a small raptor library, and hosting occasional special events for local residents and visitors also of less than 100 people.

Ms. Malone also presented to the Board for consideration of approval of a Zoning Compliance Verification for Visual Resource Analysis, pursuant to Section 8.6.2 of the Teton County Land Development Regulations, to assess foreground scenic standards. The Zoning Compliance Verification for Visual Resource Analysis included with this application demonstrates measures taken for the proposed use and development to comply with the foreground scenic standards of LDR Section 5.3.2.G.

Discussion between the Board and staff included historic building preservation, staff's interpretation of the four variances for base site area, setbacks, floor area ratio, and access drive, reviewing variances against the 1994 or 2015 LDRs, clarification on maximum occupancy, hours of operations, amending conditions, and large event monitoring.

Amy McCarthy, Executive Director at the Teton Raptor Center, addressed the Board about stewardship of wildlife, natural resources and scenery, climate sustainability through energy conservation, local workforce housing, and quality community service regarding the application and changes for the Raptor Center.

Discussion between the Board and Ms. McCarthy included public notifications process, fluctuation in staff numbers since 2008, objectives of application, specific use of property with specialized buildings and change of location of Raptor Center, timeline of events and applications reflecting on historic preservation efforts, building rehabilitation, federal standards, guidelines, and regulations for raptor rehabilitation and resident birds, spaces outlined in application, elevations of intended new development, parking, public access in raptor rehab space, visitation patterns, limited access for tour groups coming into valley, outreach programs, program fees and gift shop, and how much of Raptor Center is dependent on the enterprise portion of the business.

The meeting was recessed for lunch at 12:00pm and reconvened at 1:30pm.

Arne Jorgensen, representing the Teton Raptor Center, addressed and discussed with the Board regarding site planning and design. variance request for height, South Barn relocation, re-use of old buildings, additional condition about open ended daily total, education vs. assembly, education building where birds live.

Mark Hershberger, Hershberger Design, described the landscape plan. Discussion between the Board and Mr. Hershberger included the community feelings of the landscape screening.

Kim Cannon, Davis and Cannon Law Firm, addressed the Board regarding the 2008 Variance: is it a property right that runs with the land, can there be an FAR exchange, is there any legal impediment to the removal or replacement of the existing structures in the content of the FAR exchange, three policies to be concerned about: protection of policy rights, consistent in the LDRs to all citizens, honor past actions and approvals. Discussion between the Board and Mr. Cannon included no provision in the LDRs for historic preservation.

Roger Smith, founder of the Teton Raptor Center, addressed the Board regarding the history of the Teton Raptor Center, the vision of the Raptor Center, and long-term goals of the Raptor Center.

The meeting was recessed at 3:10pm and reconvened at 3:21pm.

Public comment was given by Ben Goldberg, Marylee White, Camille Obering, Karen Terra, Frances Clark, Beverly Boynton, David Hardie, Michael Stern, Bernie McHugh, Ann Harvey (on behalf of AJ DeRosa), Ann Harvey (on behalf of Len Carlman), Ann Harvey, Hank Phibbs, Ann Dwan, Brian Bedrosian, Jon Mobeck, Meghan Warren, Lit Clark, Leslie Peterson, Reynolds Pomeroy, and Porgy McClelland.

A motion was made by Commissioner Epstein and seconded by Commissioner Rhea to continue this item including all associated items to February 22, 2018 at 10:00am. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried.

ADJOURN

A motion was made by Commissioner Epstein and seconded by Commissioner Vogelheim to adjourn. Chair Newcomb called for the vote. The vote showed all in favor and the motion carried. The meeting adjourned at 5:00pm.
