

**SPECIAL JOINT INFORMATION PROCEEDINGS  
TOWN COUNCIL AND BOARD OF COUNTY COMMISSIONERS MEETING**

**JUNE 18, 2018**

**JACKSON, WYOMING**

The Jackson Town Council met in conjunction with the Teton County Commission in the County Chambers located at 200 S. Willow at 1:19 p.m. The Special meeting was held to interview, deliberate, and appoint a member to the JH Sustainability Project Joint Powers Board and the Jackson Hole Travel & Tourism Board. Upon roll call the following were present:

TOWN COUNCIL: Pete Muldoon Mayor, and Hailey Morton Levinson. Jim Stanford, Bob Lenz, and Don Frank were absent.

COUNTY COMMISSION: Mark Newcomb Chair, Natalia Macker Vice Chair, and Greg Epstein. Paul Vogelheim and Smokey Rhea were absent.

Paul Vogelheim and Smokey Rhea arrived at 1:22pm.

Jim Stanford arrived at 1:27pm.

Vice Chair Macker called for the vote. The vote showed all in favor and the motion carried.

On behalf of the Town, a motion was made by Councilwoman Morton Levinson and seconded by Councilman Stanford to appoint Jim Speyer and Laura Bonich to full 3-year terms on the JH Energy Sustainability Project Joint Powers Board (Energy Conservation Works) expiring June 30, 2021 and to confirm the appointment of Jim Webb representing Lower Valley Energy to a full 3-year term expiring June 30, 2021. Mayor Muldoon called for the vote. The vote showed all in favor and the motion carried.

On behalf of the Town, a motion was made by Councilwoman Morton Levinson and seconded by Councilman Lenz to appoint Brian Modena and Erik Dombroski full 3-year terms on the Jackson Hole Travel and Tourism Board expiring June 30, 2021. Mayor Muldoon called for the vote. The vote showed all in favor and the motion carried.
