Project Description:

This project will merge the space that was previously used by El Puente with the Public Health Department space. The merged space added 442 square feet of space to the patient care area of the facility, provides two more exam rooms and one more bathroom. The work will require bringing all areas affected by the change to current building code.

Project Justification (Including Relationship to Strategic Goals):

This was requested by the Public Health Department to meet their operational needs. This project will resolve building code issues relative to fire egress and permit more efficient use of staff (no additional staff will be needed to use the space) by permitting existing staff to more easily access the space. The remodel will create hallways and doorways that will permit Public Health to provide "clinics" where people can be processed through the facility in a manner that protects the privacy of the patients. This will help "Deliver efficient services to ensure the safety and welfare of residents and visitors".

This project will provide for redesign and replacement of parts of the fire control system at the Search and Rescue Building that were damaged by high ground water.

Project Justification (Including Relationship to Strategic Goals):

This system was damaged during spring flooding and needs redesign and repair to protect it from future flood events. The location of the fire control system, under the parking area, leaves it vulnerable to moisture damage from both high ground water and condensation. This project will fund a consultant to redesign the system in order to eliminate the moisture / water issues affecting the fire control system. Project Description:

This project will replace the chiller that serves the Administration Building.

Project Justification (Including Relationship to Strategic Goals):

The existing chiller has served beyond it's life expectancy. Installed when the building was built in 1994, the chiller is now over 20 years old. The life expectancy of the unit was 15 years when installed. The chiller is failing in that it often shuts down automatically and needs to be reset manually. This is analogous to an automobile that turns itself off automatically because of low oil pressure or some other internal failure. We have replaced the compressor in this unit and the unit can not be repaired in a manner that would extend it's service life further. Moreover, the refrigerant of the existing unit is being phased out of manufacturing because of it's deleterious impact on the environment (ozone depletion). Installing a new system will insure a changeover to a safer refrigerant. This project meets our Strategic Goals; Organizational Excellence - Encourage best practices. Project Description:

This project will replace the direct exchange (DX unit) air conditioning unit that serves the Courthouse. The existing unit is sixteen years old, has exceeded its life expectancy and is beginning to fail.

Project Justification (Including Relationship to Strategic Goals):

The unit is failing in that it occasionally automatically shuts down due to internal failure. More importantly, the coils are leaking and we need to regularly add refrigerant to the system. The refrigerant that leaks into the atmosphere is being phased out of manufacturing because it is an ozone depleting agent. This is an unsustainable maintenance practice and can only be remedied by replacing the unit. This project meets our Strategic Goals; Organizational Excellence - Encourage best practices.
