

Health Department and Health Order Updates – October 30, 2020



- 1) We are still in the **MODERATE (ORANGE) RISK LEVEL** for COVID-19 transmission

- 2) In the past two weeks (10/16 to 10/29) there were 100 new cases reported. This is up 23% from the previous two weeks.
 - 37 cases attributable to community spread (37%)
 - 55 cases had close contact with another known case (55%)
 - 26 cases had a history of travel (26%) – May be included in other 2 categories
- 3) As of 10/29/2020 we have 51 active cases. As of 10/29/20 there are 172 people under quarantine in Teton County. Statistics and response overview can be found [here](#).
- 4) **COVID-19 Testing Options**
 - Emerg-A-Care is no longer accepting walk-in COVID-19 testing.
 - Anyone interested in being tested, whether they have symptoms or not should call the St. John's Health hotline at (307) 739-4898 x 3.
 - Surveillance Testing is still available for local businesses. Click [here](#) to learn more and enroll.
 - Free COVID-19 Vault Test Kits available for individuals to self-administer at home. Learn more and order your free test by clicking [here](#). If you or your staff are a known contact to a positive case, please reach out to the Teton County Health Department. It is recommended to test 7 days after an exposure to someone who tested positive for COVID-19 to ensure the most accurate results.
- 5) **FREE Regular Flu Shots** are available at the Teton County Health Department walk-in flu clinic starting on Monday, November 2nd. They will be offered every Monday, Wednesday, and Friday from 8:30am-4:30pm through November 20th. The high-dose vaccine for those 65+ will also be available and will be billed to Medicare. - 7) Download the **Care19 Diary** and **Care19 Alert Apps** on your mobile device. The Care19 Diary App helps people to remember where they have been, which can help to provide more accurate information to a COVID-19 contact tracer.
