Project Description:

Extend heated concrete heli-pad to northwest to cover entire landing area.

Project Justification (Including Relationship to Strategic Goals):

The current northwest portion of the heli-pad is asphalt, which is very prone to heaving from frequent freeze/thaw. This heaving causes damage to the asphalt and heated concrete portions of the heli-pad. In addition, it contributed to flooded of the building in 2014 because the heaving caused the pad to slope toward the building. A heli-pad constructed entirely of heated concrete would prevent these problems in the future. In addition, it would provide a larger, snow-free area to take off and land the helicopter, which would be safer for the Bell 407 which SAR contracts now and also accomodate larger aircraft when needed.
