**Statement / Purpose:** Transfer of funds from the Jackson Hole Airport to 4 communities in Wyoming

**Background / Description (Pros & Cons):** The Jackson Hole Airport received FAA grants that were designated to other Wyoming communities because those cities did not have "shovel-ready" projects in place to receive the funds. This allowed the Jackson Hole Airport to complete some projects early rather than wait for the FAA funding this year. Thus, the funds were transferred to the Jackson Hole Airport with the understanding that when the Jackson Hole Airport received this year's FAA funds, the same amount of funds that were received would be transferred back to the same communities. The amounts being transferred are as follows"

Cody	\$250,000
Newcastle/Weston County	\$300,000
Torrington	\$398,981
Sheridan County	\$1,301,019

The Board of County Commissioners of Teton County, Wyoming, hereby finds as follows:

WHEREAS, Teton County and the Town of Jackson formed the Jackson Hole Airport Board (the "Airport Board") on January 17, 1968 pursuant to Wyoming Statute §10-5-202 and 16-1-105; and

WHEREAS, as such the Airport Board is authorized to receive certain grants from Federal Aviation Administration ("FAA") from time-to-time in relation to the operation of the Jackson Hole Airport (the "Airport"); and

WHEREAS, the Airport Board, and the Town of Jackson and Teton County as co-sponsors, previously accepted the transfer of FAA entitlement grant funding in the amount of \$250,000 from the City of Cody, Wyoming; \$300,000 from the City of Newcastle and Weston County, Wyoming; \$1,301,019 from Sheridan County, Wyoming; and \$398,981 from the City of Torrington, Wyoming; and

**WHEREAS**, the receipt of such grant funding was subject to an agreement that the Airport Board, and the Town of Jackson and the Teton County as co-sponsors, would transfer entitlement funds in the same amount back to said airport sponsors from the Airport Board's FY 2022 FAA grant funds; and

WHEREAS, the Airport Board, the Town of Jackson and the County of Teton as co-sponsors, now wish to transfer back to said local governments a portion of the Airport Board's FAA entitlement grant funding for FY 2022, in the amounts set forth above and in accordance with their prior agreement; and

WHEREAS, approval and acceptance by Teton County, the Town of Jackson and the Airport Board, each as a co-sponsor under FAA requirements, are all required to effectuate such transfers; and

WHEREAS, the Teton County Board of County Commissioners desires as a co-sponsor to approve the transfer of such amounts of FAA grant funding, and to authorize the appropriate officers of Teton County to execute the associated agreements, in the forms annexed hereto as **Exhibit A**.

NOW, THEREFORE, it is resolved by the Teton County Board of County Commissioners, in open and public meeting as follows:

1. Teton County, as a co-sponsor hereby approves the transfer of portions of the Airport Board's FY 2022 FAA entitlement grant funding in the amount of \$250,000 to the City of Cody, Wyoming; \$300,000 to the City of Newcastle and Weston County, Wyoming; \$1,301,019 to the Sheridan County, Wyoming; and \$389,981 to the City of Torrington, Wyoming.

2. The Board of County Commissioners of Teton County hereby designate and approve the Chair of the Teton County Board of County Commissioners to execute documents on behalf of the Board to accomplish such transfer, and ratifies and approves any such execution whether made before or after the date of this Resolution.
