**Submitting Dept:** Public Works - Engineering **Subject:** Consideration of Swinging Bridge Bid Concurrence

---

**Statement/Purpose:** To provide concurrence to fund the County's match portion of the Swinging Bridge project.

**Background / Description (Pros & Cons):** Swinging Bridge is slated for reconstruction and has been in planning and design through the WYDOT bridge replacement off system (BROS) program for several years. This program provides local government with a federal funding source for large bridge replacements that otherwise would be financially challenging projects for local governments. The project was bid out, with bids due on September 14, 2023. WYDOT received one bid from Reiman Corp. for \$10,340,122. The engineer's estimate was \$6.7M.

Because there is a 9.51% match payment required from the County, formal written concurrence is required for WYDOT to accept the bid. If the County concurs, the WYDOT Transportation Commission will ultimately determine if the bid is awarded.

**Stakeholder Analysis & Involvement:** Traveling public, area neighbors, Bridger-Teton National Forest, Jackson Hole Historical Society

**Fiscal Impact:** Teton County previously entered into a cooperative agreement with WYDOT for this project. The County's match is 9.51% of the total project costs, which is \$1,301,107.10. Part of this has already been expended for preliminary engineering and right-of-way as outlined in the attached Exhibit B.

\$750,000 is budgeted for this project in FY24 in County Road Fund 18. The balance will be budgeted in FY25. Construction is expected to begin in Fall 2023 and continue through the summer of 2024, which spans the two fiscal years.

**Staff Impact:** County public works staff will be somewhat involved if the project is awarded, however WYDOT staff will manage the day to day construction administration.

**Legal Review:** Gingery

**Staff Input / Recommendation:** Staff recommends concurring to award the project.

**Suggested Motion:** I move to approve the letter to the WYDOT Transportation Commission concurring with the bid results and agreeing to the County's match of 9.51% for the Swinging Bridge Replacement project through the WYDOT Bridge Replacement Off System Program.
