**Subject:** Consideration of FY2026 Fees for ISWR Public Hearing

---

**Statement / Purpose:** To consider proceeding with the public hearing for the adoption of fees for the Teton County Transfer Station, Recycling Center, and Household Hazardous Waste Facilities for FY2026 (July 1, 2025-June 30, 2026).

**Background / Description (Pros & Cons):** Teton County Integrated Solid Waste and Recycling (ISWR) is proposing to increase fees at the Recycling Center, the Household Hazardous Waste (HHW) program, and the transfer station for FY2025. Attached are the current and proposed fee increases. Advertising occurred over 45 days beginning on May 7, 2025.

**Stakeholder Analysis & Involvement:** Fees paid by myriad entities and persons (i.e., TTS, recycling, and HHW customers).

**Fiscal Impact:** As a self-funded enterprise fund, ISWR relies on fee increases to offset rising expenses. Many of ISWR's multi-year contracts include built-in escalators ranging from 2-6%. The FY2026 budget reflects an overall increase of 6%.

**Staff Impact:** ISWR staff will communicate, collect, and track new and updated fees for service.

**Legal Review:** Gingery

**Staff Input / Recommendation:** Staff recommends the adoption of the FY2026 fees for the Teton County Trash Transfer Station, Recycling Center, and Household Hazardous Waste Facilities.

**RESOLUTION #**

**(Fees for the Teton County Trash Transfer Facility, the Teton County Recycling Facility, and the Teton County Household Hazardous Waste Facility)**

**WHEREAS**, the Teton County Board of County Commissioners operate on behalf of Teton County, Wyoming, the Teton County Trash Transfer Facility, the Teton County Recycling Center, and the Teton County Household Hazardous Waste Facility; and

**WHEREAS**, the Teton County Board of County Commissioners are authorized as the owner and operator of the Teton County Trash Transfer Facility, the Teton County Recycling Center, and the Teton County Household Hazardous Waste Facility to set the fees for use, disposal, and services at the Teton County Trash Transfer Facility, the Teton County Recycling Center, and the Teton County Household Hazardous Waste Facility; and

**WHEREAS**, pursuant to Wyoming Statute §16-3-103, the Teton County Board of County Commissioners gave 45-day notice of their intent to adopt these fees for the Teton County Trash Transfer Facility, the Teton County Recycling Center, and the Teton County Household Hazardous Waste Facility; and

**WHEREAS**, the tip fees as delineated below, will go into effect as of July 2, 2025.

**NOW THEREFORE**, having met at a regular meeting on this \_\_\_\_\_ day of July 2025, and having fully considered the matter, it is hereby,

**RESOLVED**, that the Teton County Board of County Commissioners approves and adopts the following fees, which shall be in effect July 2, 2025, until the next resolution is approved by the Teton County Board of County Commissioners, of which the fees shall be set as follows:
